02-47 COMMUNICATIONS

1. Letter from TE W. Channell requesting that presbytery be called to meet. With all requirements having been met the call of this presbytery meeting was found to be in order.
2. Letter from the congregation of Redeemer Community Church, Mobile, AL informing presbytery of her withdrawal from Gulf Coast Presbytery. Motion and made and carried that this communication be referred to the Minister's and Candidates Committee.

02-48 APPROVAL OF THE DOCKET

A motion was made and seconded that that the docket be approved as presented and the motion carried.

02-49 REPORTS

A. EXMANINATIONS – TE W. CHANNEL

- Examination, Reception and Approval of Call for TE Robert Looper

1 TE Dennis Eide, pastor elect of Christ Presbyterian Church, was
2 introduced to the Presbytery. Mr. Eide is a member in good standing in
3 Northern Illinois Presbytery.

4 TE Dennis Eide was first examined in the area of his Christian experience
5 and call to ministry at McIlwain by RE R. Myers. This portion of the
6 examination was arrested.

7 TE J. Foster next examined Mr. Eide in area of his theological views.
8 Moved and approved that this portion of the exam be arrested.

9 TE Channel examined Mr. Eide on views in the area of polity. This portion
10 was also arrested.

11 TE Channel examined Mr. Eide on views in the area of sacraments. This
12 portion was also arrested.

13 The examination was then arrested.

14 The Presbytery found that Mr. Eide held one exception to the WCF 24-3
15 and it is recorded below:

16 “Statement is made that, ‘it is the duty of Christians to marry only in
17 the Lord. And therefore such as profess the true reformed religion
18 should not marry with infidels, papists, or other idolaters’. I
19 disagree with the implied thought that all ‘papists’ – (Roman
20 Catholics) are outside of the Lord. While I would counsel and warn
21 against the Roman church’s doctrine of justification and would
22 encourage Catholics to leave the Roman Church, I do believe that
23 there are true believers that are Roman Catholic. I would also
24 counsel against a marriage where a Protestant believer wants to
25 marry a Roman Catholic believer who desires to remain a part of
26 the Roman church. However, I think it goes beyond Scripture to
27 forbid such a marriage.”

28 Following discussion the Presbytery granted the exception of Mr. Eide.

29 The examination was then sustained as a whole.

30 The call was then prosecuted by RE Charles Grey who read the call and
31 its terms before Presbytery. The call was found in order and, being
32 acceptable to Mr. Eide, was then placed in his hands (See [Appendix A](#)).
33 A motion was made and approved that Presbytery establish the following
34 commission to install TE Eide.

35 Members of the Commission: TE’s Jim Bryars, John Mathieu, Doug
36 Miller, Bruce O’Neil, and Chuck Phillips. RE’s Dick Buchanan,
37 Charles Gray, and Gene New.
