18 Chairman W. Channell opened the report of the examinations committee
19 with prayer and introduced the Reverend Tim Locke to presbytery. Mr.
20 Locke was ordained by the Faith Baptist Church (Independent), Taylors,
21 South Carolina. He has been called to serve as an assistant pastor by
22 the Pinewoods Presbyterian Church in Pensacola, FL.

23 RE R. Myers examined him on the area of his Christian experience and
24 sense of call to the ministry. A motion was made and carried to arrest this
25 portion of the exam.

26 TE B. Tyson then examined Mr. Locke in area of Theology. A motion was
27 made and carried to arrest this portion of the exam.

28 TE S. Cloud then examined Mr. Locke in area of English Bible. A motion
29 was made and carried to arrest this portion of the exam.

30 TE S. Cloud then examined Mr. Locke in area of Polity. A motion was
31 made and carried to arrest this portion of the exam.

32 TE W. Channel then examined Mr. Locke in area of Church History. A
33 motion was made and carried to arrest this portion of the exam.

34 TE S. Cloud then examined Mr. Locke in area of Sacraments. A motion
35 was made and carried to arrest this portion of the exam.

36 A motion was made to sustain the examination of Mr. Locke as a whole and
37 noting that he has no exceptions to the Westminster standards.

1 A motion was made and carried that we receive Mr. Locke into Gulf Coast
2 Presbytery upon his signing the book of ministerial obligations.

3 The terms of the call Pinewoods Presbyterian Church were read,
4 approved, and found acceptable to Mr. Locke and placed in his hands.

20 **PRESBYTERY RECONVENED**

21 The Moderator called presbytery to order and led in prayer. Presbytery
22 reconvened following lunch at 12:04 (CST).

23 **05-54 EXAMINATIONS CONT'D – TE W. CHANNELL**

24 TE W. Channell continued the report of the examinations committee by
25 introducing Mr. Justin Stodghill to the presbytery. Mr. Stodghill is being
26 examined for licensure in Gulf Coast Presbytery. Mr Stodghill has
27 attended Whitefield Theological Seminary.

28 RE R. Myers examined Mr. Stodghill in the area of Christian experience
29 and sense of call to the ministry. A motion was made and carried to arrest
30 this portion of the exam.

31 Mr. Stodghill's trial sermon and sermon manuscript was approved.

32 TE B. Tyson then examined Mr. Stodghill in area of Theology. A motion
33 was made and carried to arrest this portion of the exam.

34 TE S. Cloud then examined Mr. Stodghill in area of Polity. A motion was
35 made and carried to arrest this portion of the exam.

1 TE S. Cloud then examined Mr. Stodghill in area of English Bible. A
2 motion was made and carried to arrest this portion of the exam.

3 A motion was made to arrest and sustain the examination of Mr. Stodghill
4 noting that he has no exceptions to the Westminster standards.

5 The questions of licensure were then put to him and affirmed. A suitable
6 charge was given by TE B. O'Neil who also prayed for Mr. Stodghill.

7 At Panama City, FL, the eleventh day of October, 2005, the Gulf Coast
8 Presbytery, having received testimonials commending Mr. Justin Stodghill,
9 proceeded to submit him to the prescribed examination for licensure, which
10 was met to the approval of the Presbytery. Having satisfactorily answered
11 the questions for licensure, Mr. Stodghill was licensed by the Presbytery to
12 preach the Gospel within the bounds of this Presbytery.

13 **SPECIAL ORDER: REPORT OF THE AD HOC COMMITTEE ON HANDLING**
14 **OUT-OF-BOUNDS CALLS – TE B. O'Neil**

15 A draft proposal on the nature of the call of teaching elders and the handling
16 of out-of-bounds calls was presented to presbytery for further study. The
17 report was tabled for a vote at the next meeting of presbytery.

18 **05-55 MISSION TO NORTH AMERICA - TE C. RYOR, CHAIRMAN**

19 TE C. Ryor presented the report to Presbytery.

20 TE D. Anderegg gave an update report on the work of Disaster Relief in Gulf
21 Coast Presbytery. The presbytery has been at the fore front of initial relief in the
22 wake of hurricane Katrina.

23 TE C. Ryor gave an update on the work of the CenterPoint Mission and the re-
24 plant of Faith Presbyterian Church in Robertsedale, AL.

25 A motion was made to amend the proposed MNA Budget to authorize the
26 following item:

- 28 • That revitalization funding the church planter for the replant of Faith PC in
29 Robertsedale and Loxley Presbyterian Churches in Alabama at our
30 standard church planting funding arrangement of \$1,500 per month for the
31 first year, \$1,000 per month for the second year, and \$500 per month in
the third year.

32 **05-56 CHRISTIAN EDUCATION – TE BENNY YOUNGBLOOD, CHAIRMAN**

33 Mr. Youngblood presented the report to presbytery. He informed the presbytery

1 of several conference opportunities and resources for PresWIC, Youth and
2 Children's Ministries. He also encouraged all presbyters to attend the Overnight
3 Presbytery Meeting, February 13-14, 2006.

5 resource information.

6 **05-57 MINISTERS & CANDIDATES – TE R. DEKKER**

7 TE R. Dekker presented the report to presbytery.

8 TE Dekker gave a follow-up status report on the relationship of the First
9 Presbyterian Church of Niceville, Florida and TE M. Swain, the former senior
10 pastor. Both TE M. Swain and TE J. Grider, current senior pastor, indicated that
11 a healthy relationship exists between TE Swain, the Session, and congregation
12 of First Presbyterian Church where they are regularly attending. Mrs. Swain will
13 soon become a member of the congregation.

14 The following recommendations were adopted by presbytery.

15 1. We move the adoption of the following:

16 Whereas, it is the responsibility of Presbytery through the Ministers and
17 Candidates Committee to provide written notification of the GCP's ministry
18 requirements which are to be consistent with the academic standards spelled
19 out in the Uniform Curriculum for Theological Education (BCO 21-4) to the
20 intern, prior to the commencement of his period of internship (GCP 407-2),
21 and

22 Whereas, it is the responsibility of Presbytery to determine the nature of the
23 requirements (BCO19-7), involving the full scope of the duties of any regular
24 ministerial calling, and

25 Whereas, it is within the scope of Presbytery's responsibility to determine
26 what is suitable to best test an intern's gifts (BCO-19-7), and

27 Whereas, areas not covered satisfactorily in the candidates choice of
28 seminary are to addressed through a candidates' internship testing (BCO 21-
29 4),

30 Be it resolved that the current "Gulf Coast Presbytery Internship Criteria
31 Guide" and "Internship Checklist for the Gulf Coast Presbytery" be utilized as
32 the minimum standard for the Gulf Coast Presbytery's internship expectations
33 when developing each person's tailored internship checklist (which may at the
34 discretion of the Ministers and Candidates Committee and the intern's
35 mentor, require the substituting of redundant activities with particular activities

1 that will more acutely address the candidates known areas of weakness), and
2 Be it further resolved that such a personalized Internship will commence with
3 the approval of the Presbytery (BCO 19-10).

4 2. We move the following motion:

5 Whereas the BCO requires an annual report to Presbytery by all Candidates
6 (BCO 18-6 & GCP Standing Rules 407-1b),

7 Whereas the BCO requires an annual reporting by all interns of their progress
8 (see BCO 19-12 and GCP Standing Rules 407-2a),

9 Whereas the BCO 8-7 requires the annual reporting of all Teaching Elders
10 who are laboring out-of-bounds, and

11 Whereas the GCP Standing Rules require the MAC to provide its report at the
12 May Stated Meeting,

13 Whereas the neglect of regular annual reporting has provided confusion and
14 has not received due process,

15 Be it resolved that all annual reporting be submitted by April 15th of each year
16 to the Clerk of Presbytery (and a copy of that report be forwarded to the
17 Chairman of the Ministers and Candidates Committee.

18 3. We move the following motion:

19 Whereas it has been noted by the Ministers and Candidates Committee that
20 TE Tim Spilman continues to be without a call for a period now exceeding
21 three years (BCO 13-2), and

22 Whereas it is the duty of the Presbytery to inquire into the matter (BCO 34-10)
23 and if necessary to divest him of his office (BCO 34-10),

24 Be it resolved that the Gulf Coast Presbytery order the clerk proceed with the
25 process outlined in BCO 34-10, seeking TE Spilman to address this matter in
26 person at our next stated meeting.

27 4. We move that GCP approve the initiation of the internship request by Al
28 Ward. That Al Ward, having been previously taken under care as a candidate
29 and having been examined in the area of Christian experience and sense of
30 call to ministry, be approved for licensure. Presbytery accepted Mr. Ward's
31 previous statement of Christian Experience and sense of call to the ministry
32 as meeting the BCO requirements for licensure.

1 5. We move that GCP approve the request dated on August 6, 2005, from the
2 Clerk of the Western Carolina Presbytery to dismiss TE Josiah Bancroft to
3 their presbytery so that he may serve at the Grace Community Church in
4 Fletcher, NC.

5 6. We move that Mr. Justin Stodghill be taken under care of Gulf Coast
6 Presbytery. Mr. Stodghill is a member of the Westminster Presbyterian
7 Church, Milton, FL. He has been endorsed by the Session and has submitted
8 an application to the clerk. Presbytery accepted Mr. Stodghill's statement of
9 Christian experience and call to the ministry as given during his licensure
10 exam (see 05-54) as meeting the requirement for candidacy.

11 The moderator proposed the questions which were answered in the
12 affirmative. TE B. O'Neil delivered the charge and led in prayer in Mr.
13 Stodghill's behalf.

14 TE Dekker closed the report with prayer. See **Appendix I** for Ministers
15 and Candidates full report.

16 **05-58 MISSION TO THE WORLD – TE S. BRADFORD**

17 The Mission to the World report was given by TE S. Bradford in the absence of
18 the chairman, TE Dewey Roberts. Mr. Roberts is on active duty with the National
19 Guard.

20
21 TE Bradford introduced Stephanie Pike who a missionary with MTW in France.
22 She gave a report of her work there and God's continuing work in France.

23
24 Mr. Kent Ferguson also gave a report on their work with MTW in the
25 development of a support network for missionaries called the "Safety, Awareness
26 and Crisis Response Program".

27
28 TE S. Bradford gave an update on the work of Church Planting International.

29
30 The report was approved a whole and TE B. Hayes closed with prayer.
31

32 **05-59 FLORIDA JOINT COMMISSION ON RUF - TE B. HAYES**

33 TE B. Hayes gave the report on the works involving seven different RUF
34 ministries in the state of Florida. TE David Story gave an oral report of the work
35 of RUF at Florida State University.

The Commission meeting was opened with prayer by TE Bob Evans. TE Bob Evans was elected chairman and TE Ed Hague was elected Secretary of the Commission. The Commission recessed with prayer by TE Bob Evans for the ordination/installation service.

The Chairman stated briefly the previous proceedings of the Presbytery, and pointed out the nature and importance of the installation ordinance.

**Terms of Call for Timothy R. Locke as Assistant Pastor
of Pinewoods Presbyterian Church**

The Pinewoods Presbyterian Church (PCA) being on sufficient grounds well satisfied of the ministerial qualifications of you, Rev. Timothy R. Locke, and having good hopes from our knowledge of your labors that your ministrations in the Gospel will be profitable to our spiritual interests, do earnestly call you to undertake the pastoral office in said congregation, promising you, in the discharge of your duty, all proper support, encouragement and obedience in the Lord. 25 of his Presbytery, at home or abroad, it shall be only with the full concurrence of
26 and under circumstances agreeable to his Presbytery, and to the Presbytery
27 within whose geographical bounds he labors, if one exists. When a minister shall
28 continue on the rolls of his Presbytery without a call to a particular work for a
29 prolonged period, not exceeding three years, the procedure as set forth in BCO
30 34-10 shall be followed.

31
32 **34-10.** Whenever a minister of the Gospel shall habitually fail to be engaged in
33 the regular discharge of his official functions, **it shall be the duty of the**
34 **Presbytery, at a stated meeting, to inquire into the cause of such**
35 **dereliction and, if necessary, to institute judicial proceedings against him**
36 **for breach of his covenant engagement.** If it shall appear that his neglect
37 proceeds only from his lack of acceptance to the church, Presbytery may, upon
38 the same principle upon which it withdraws license from a licentiate for lack of
39 evidence of the divine call, divest him of his office without censure, even against
40 his will, a majority of two-thirds (2/3) being necessary for this purpose.
41 In such a case, the clerk shall under the order of the Presbytery forthwith deliver
42 to the minister concerned a written note that, at the next stated meeting, the
43 question of his being so dealt with is to be considered. This notice shall distinctly
44 state the grounds for this proceeding. The party thus notified shall be heard in his
45 own defense; and if the decision pass against him he may appeal, as if he had

1 been tried after the usual forms. This principle may apply, with any necessary
2 changes, to ruling elders and deacons.)

5 Whereas, it is the responsibility of Presbytery through the Ministers and
6 Candidates Committee to provide written notification of the GCP's ministry
7 requirements which are to be consistent with the academic standards spelled out

9 prior to the commencement of his period of internship (GCP 407-2), and

10 Whereas, it is the responsibility of Presbytery to determine the nature of the
11 requirements (BCO19-7), involving the full scope of the duties of any regular

13 Whereas, it is the within the scope of Presbytery's responsibility to determine
14 what is suitable to best test an intern's gifts (BCO-19-7), and

15 Whereas, areas not covered satisfactorily in the candidates choice of seminary
