22 **07-28 EXAMINATIONS – TE S. CLOUD**

23 TE S. Cloud opened with prayer and re-introduced Mr. Win Groseclose to
24 presbytery. Mr. Groseclose is a MDiv. Graduate of Reformed Theological
25 Seminary. He has previously been examined in the areas of English Bible,
26 Church Government (Polity) and Theology for licensure. Mr. Groseclose is a
27 candidate in Gulf Coast Presbytery and is coming today for the completion of his
28 examination for ordination. He has been received a call as Pastor of Westminster
29 Presbyterian Church, Milton, Florida. Presbytery voted to proceed with the
30 examination.

31 Presbytery accepted the sermon manuscript and the sermon preached for
32 licensure as meeting the requirements for ordination.

33 RE R. Myers examined Mr. Groseclose in the area of his Christian Experience
34 and sense of call to the ministry. A motion was made and carried to arrest this
35 portion of the exam.

36 Presbytery accepted Mr. Groseclose's seminary study in Greek and Hebrew as
37 meeting the requirements for ordination.

38 TE S. Cloud examined Mr. Groseclose in the area of Church History. After

1 questions from the floor, this portion of the examination was arrested.

2 Mr. Cloud examined Mr. Groseclose in the area of the Sacraments. After
3 questions from the floor, this portion of the examination was arrested.

4 Mr. Groseclose stated that his views had not changed since his examination for
5 licensure. He takes no exceptions to the Book of Church Order and the
6 Westminster Standards. This portion of the examination was arrested.

7 A motion was made and carried that the examination be approved as a whole
8 and that he be approved for ordination by Gulf Coast Presbytery.

9 The terms of the call to the Mr. Groseclose were read, approved, and found
10 acceptable to Mr. Groscclose and placed in his hands. **(Appendix E)**

Presbytery recessed for lunch at 11:15 AM. The moderator led in a prayer of thanksgiving for God’s gracious provision for lunch and fellowship.

9 TE D. Anderegg presented the report to Presbytery.

18 TE D. Anderegg closed the report with prayer asking God's blessing on the
19 committee and its work. The report as a whole was received.

20 **07-33 FLORIDA JOINT COMMISSION ON RUF - TE B. HAYES, CHAIRMAN**

21 TE B. Hayes presented the report to presbytery.

26 Florida State University. TE Story also introduced TE Richard Vice,

31 TE D. Shackelford presented the Administration Committee's report to

2. That Christ Community, Pensacola, FL has not submitted any records for review since February of 2005. I spoke with Randy Peacock (their clerk of session). Who promised to report in at the 103rd Stated Meeting. At the time of the 103rd Stated meeting we believed that this had not yet happened and the Presbytery instructed me to send a certified return receipt letter to the Session of Christ Community church to remind them that the Book of Church order 40-1 states that: *It is the right and duty of every court above the Session to review, at least once a year, the records of the court next below, and if any lower court fails to present its records for this purpose, the higher court may require them to be produced immediately, or at any time fixed by this higher court.* With the warning that if they did not make progress to be in compliance by the 104th Stated meeting (in May of 2007) of Presbytery, that this Presbytery will take appropriate action.

Update 02/07/07: The clerk of Session had attempted delivery prior to the meeting, however, they were delivered to the wrong church. The package was not received until after the meeting. No letter will be sent by the Administrative Committee to Christ Community Church.

An Exception of Substance was noted: There was a called meeting of the Session on November 29, 2006 and again on December 15th and 18th, 2006 which intentionally excluded the Pastor/ Moderator. (BCO 12-1)

Action Item from The 104th Stated Meeting of Presbytery: The Gulf Coast Presbytery directed the Stated Clerk (TE: Robert Hornick) and the current Moderator (TE: Chuck Ryor) at it's 104th Stated Meeting to meet with the Session of Christ Community Church in Pensacola, FL concerning their violation of BCO

1 12-1 and to report back with the results of that meeting at the 105th Stated
2 Meeting.

4 3. The Session records of First Presbyterian Church, Atmore, AL were last
5 scheduled for review at the May 2006 Stated meeting, however a request for
6 deferment was sought by and granted to the church with the promise that their
7 records would be presented for review at the October 2006 Stated meeting. First
8 Presbyterian Church, Atmore failed to produce their records at the October 2006
9 Stated Meeting. A second written request was issued to their Clerk of Session
10 prior to the February 2007 Stated Meeting and again First Presbyterian Church
11 Atmore failed to comply with our written request to present records at the
12 February 5th & 6th, 2007 Stated Meeting. Therefore the Presbytery instructed
13 me to send a second certified return receipt letter to the Session of First
14 Presbyterian Church in Atmore, AL.

12 chairman and Mr. Hayes secretary.


13 The order of service was reviewed and approved and the commission retired to the sanctuary

19 pronounced the proper installation of Mr. Lamkin.


20 Mr. Hayes then delivered a charge to the Mr. Lamkin and Mr. Watson a charge to
