35 **08-25 MINISTERS & CANDIDATES – TE R. DEKKER, CHAIRMAN**

36 TE R. Dekker presented the report to presbytery. He opened the report with
37 prayer.

19 TE David Crenshaw presented an oral report the presbytery. Mr. Crenshaw
20 reported that there were no examinations or receptions of candidates on the
21 docket for this meeting.

24 **08-27 CHRISTIAN EDUCATION – TE B. PULLEN, CHAIRMAN**

25 TE B. Pullen opened with prayer and presented the report to presbytery.

27 **08-28 MISSION TO NORTH AMERICA - TE J. BRYARS, CHAIRMAN**

28 TE J. Bryars presented the report to Presbytery.

29 1. TE Joe Elliott reported on the progress of the Door of Hope Mission. Joe
30 reported that there has been some setting back in their numbers but that the
31 ministry is stable and looking for more families to help in expanding the core
32 of the new work. All PCA churches are being asked to consider sending seed
33 families to help with the strengthening of the mission church.

1 2. TE's Joe Grider and Bill Tyson gave an update on the progress toward a
2 future of church planting in the Crestview area. They indicated that they have
3 submitted a site profile to MNA and that the future work is being listed on
4 MNA's bulletin boards.

5 TE J. Bryars closed the report with prayer asking God's blessing on the
6 committee and its work. The report as a whole was received.

7 **08-29 MISSION TO THE WORLD - TE R. LAGUARDIA, CHAIRMAN**

8 TE R. LaGuardia, chairman of the MTW Committee, opened with prayer and
9 gave a summary of TE Dewey Robert's trip to Kazan, Russia. Mr. Roberts
10 delivered copies of Calvin's Institutes for 16 seminary students at the seminary
11 purchased by Gulf Coast Presbytery. He was at the seminary the week of
12 presbytery teaching and not able to give his report.

13
14 TE Bob Hayes gave a report on his activities as Associate Pastor for Missions
15 and encouraged the presbytery with regard to overseas missions as well as
16 home missions. Bob also volunteered to assist local churches and missions
17 committees in their participation and involvement in mission trips and
18 conferences.

19
20 Dr. Paul Fellers from Bayside Medical Missions gave a presentation to
21 presbytery concerning the mission's work in Ecuador.

22
23 RE Bob Cooper concluded the report with prayer.

25 Dr. Paul Long from RTS shared with presbytery in regards to the Doctor of
26 Ministry degree at RTS and it's value to pastors as they continue their ministries
27 with renewed vision and hope.

29 The commissioners gathered in small groups for sharing and prayer.

30 **SPECIAL ORDER – 12:00 – 12:45 – LUNCH**

32 Presbytery reconvened at 1:15 PM. TE Win Groseclose led the presbyters in
33 prayer.

34 **08-30 FLORIDA JOINT COMMISSION ON RUF - TE B. HAYES, CHAIRMAN**

35 TE B. Hayes presented the report to presbytery.

1 Mr. Hayes reported that are ongoing discussions with the Alabama Joint RUF
2 Committee to begin an RUF work at the University of South Alabama.

3 TE David Story presented an oral report on the work at FSU. Mr. Hayes prayed
4 for the ministry at FSU.

5 Mr. Hayes closed the entire report in prayer.

6 **08-31 ADMINISTRATION – TE D. SHACKLEFORD, CHAIRMAN**

7 TE D. Shackelford presented the Administration Committee's report to
8 presbytery. The following recommendations were adopted.

4 **08-33 OLD BUSINESS**

5 Report of the Ad-Interim Committee on Sabbath Observance – TE Bill Tyson
6 reported that the committee to study the “Sabbath exception issue” had wanted
7 to present a little fuller study than only that pertaining directly to the issue of what
8 constituted an exception. The committee has developed some guidelines, but
9 would prefer to perfect them further and present a final report at the October
10 Stated Meeting.

11 TE W. Tyson reported the committee has continued to work and was close to
12 being able to present a final report to the presbytery. Presbytery continued the
13 committee until the Fall Meeting of Presbytery.

14 **08-34 NEW BUSINESS**

15 Time & Place of the 108th Stated Meeting. – Presbytery accepted the invitation of
16 the Eastern Shore Presbyterian Church to host the Fall Meeting of presbytery.

17 **08-35 REPORTS OF STANDING COMMITTEES & COMMISSIONS**

18 **1. Kings Bay Commission**

19 TE Bill Tyson presented the report to presbytery. At the direction of Presbytery
20 RE Earl Smith and TE Bill Tyson, members of the King’s Bay Commission, TE
21 Jim Bryars and TE Dave Anderegg of the MNA Committee and TE Robert
22 Dekker of the Ministers and Candidates Committee, met with TE Scott Seidler,
23 pastor of King’s Bay, on April 10, 2008, to discuss the situation and future of the
24 King’s Bay Mission Church. Following this meeting, the Commission met by
25 conference call on May 1, 2008. After much discussion the committee came to
26 the conclusion that the best course would likely be to dissolve the relationship
27 between Gulf Coast Presbytery and King’s Bay *unless* the Panama City churches
28 could offer some personnel support and oversight, and to discuss the matter with
29 TE Seidler and the King’s Bay mission to allow them time to consider their
30 options. It was the intention of the Commission to discuss the matter with TE
31 Seidler at the May Stated Meeting, but a rough draft copy of the Commission’s
32 report was mistakenly sent to him containing a recommendation saying: “After
33 careful consideration of the facts and after personal interaction with TE Seidler,
34 the King’s Bay Commission observed an unhealthy state of this mission and
35 recommends dissolution of its relationship with the Gulf Coast Presbytery to be
36 effective in the October Meeting of Presbytery.” That statement did not reflect

1 the entire intent of the Commission. Furthermore, it would likely have been
2 amended had it only been received by the members of the Commission as
3 intended by the drafter. However, having received the draft, TE Seidler
4 responded on behalf of the Kings' Bay Mission by answering the rationale of the
5 Commission's report, and by arranging for a group from the Kings' Bay Mission
6 to meet with the Commission at the May Meeting. That meeting is still in process
7 and therefore the Commission requests that its report be postponed, and that
8 prior to the October meeting, members of the Commission meet with the pastors
9 of the Panama City PCA churches to see if there was the possibility of those
10 churches coming along side of King's Bay in order to give some personnel and
11 leadership support for King's Bay, and also to address some relational problems
12 between King's Bay and the Panama City Churches.

26 *corporate and individual needs and comfort as a Presbytery in Session*
27 *this 13th day of May, 2008.*
